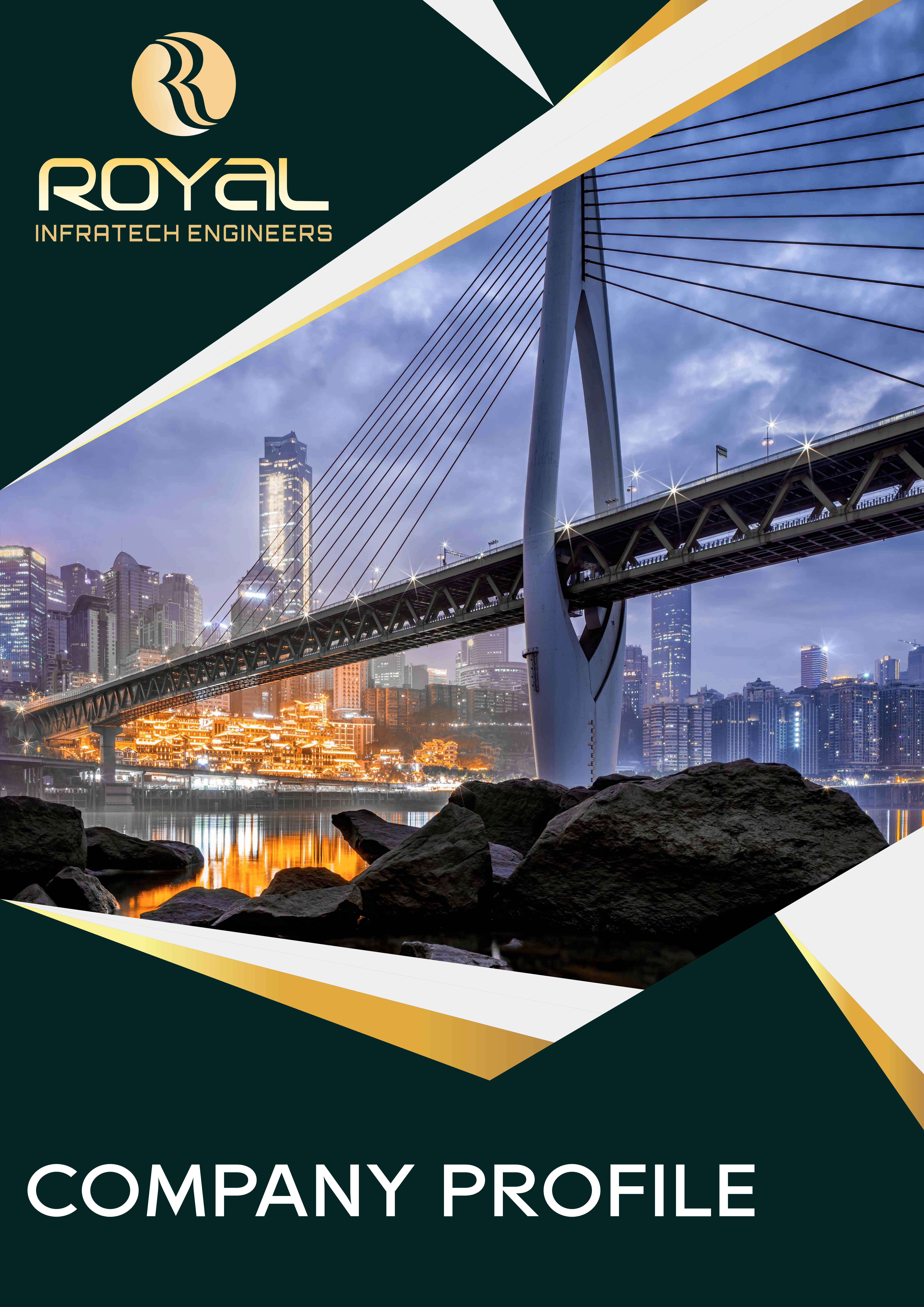

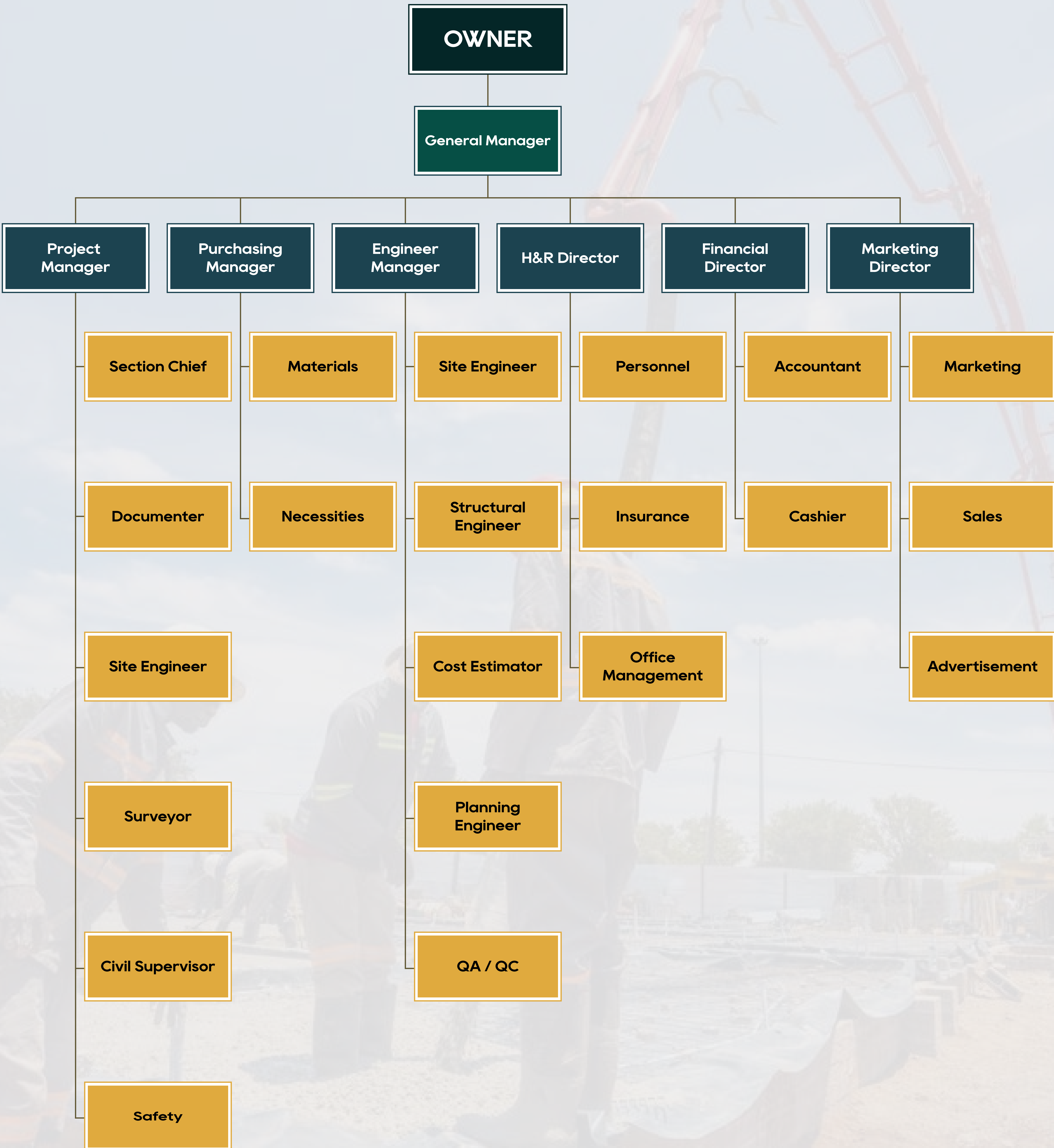

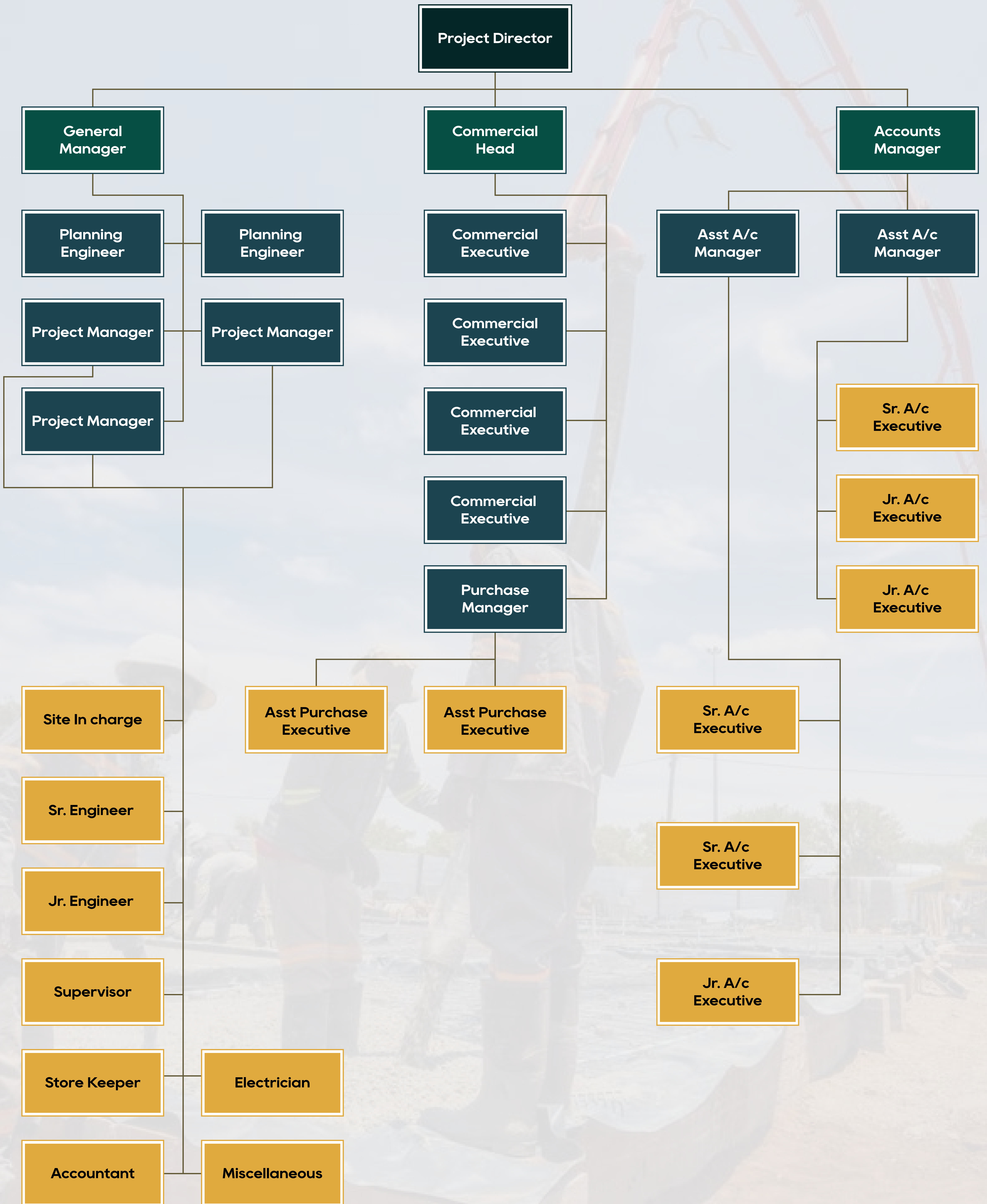

SITE ORGANIZATIONAL STRUCTURE

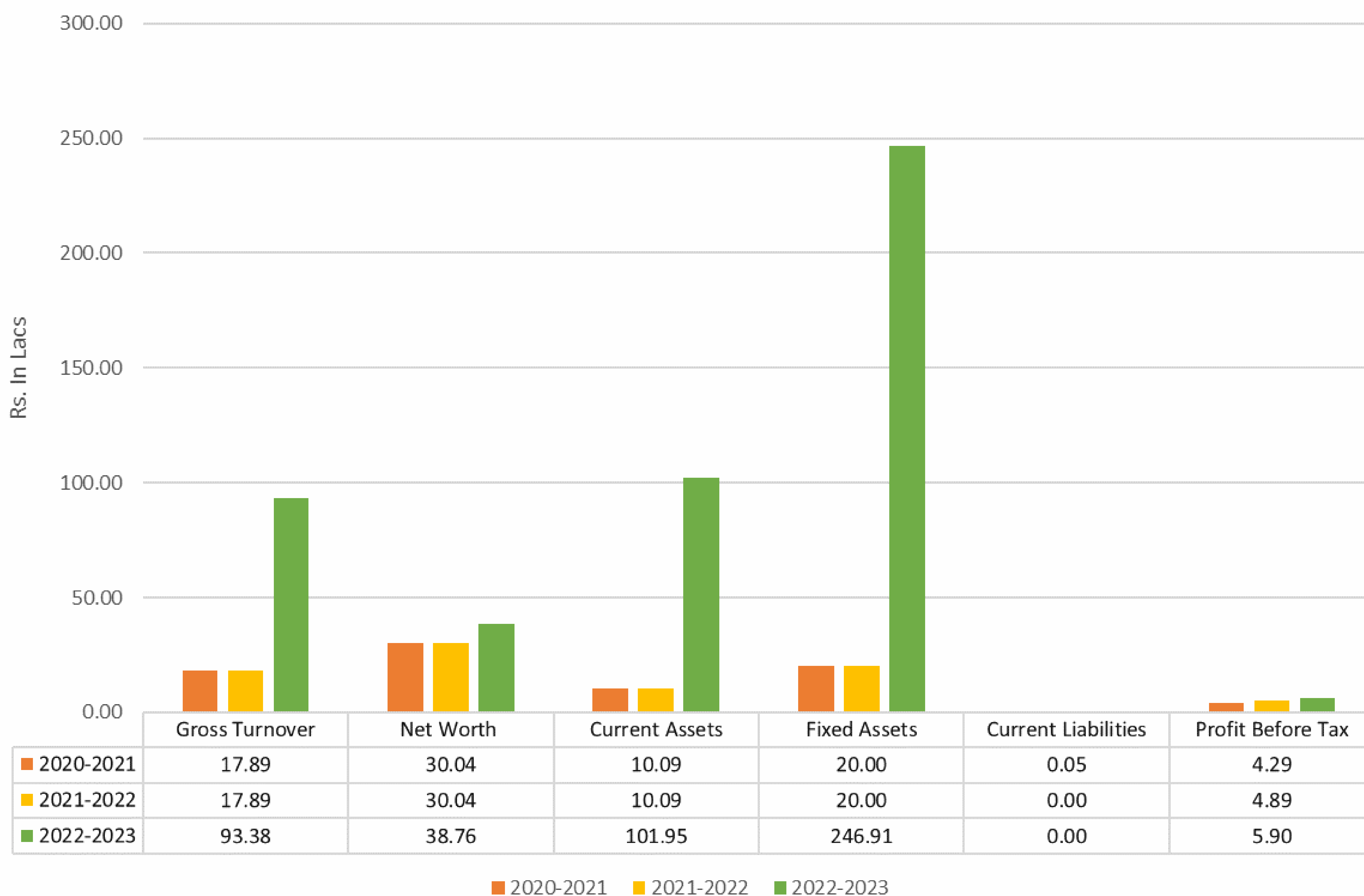
